

EU REACH Compliance Recommendations in the Supply Chain

Registration

REACH24H Consulting Group Located in Ireland has been appointed by non-EU manufacturers as the Only Representative to successfully complete registrations according to EU REACH. Non-EU manufacturers are suggested to decide own registration strategy according to the actual trade situation, and REACH24H Consulting Group will only start to carry out a registration if authorization is formally given from the Non-EU manufacturer. Please pay special attention if any substance (s) shown in the table above have been registered as intermediate under SCC (strictly controlled conditions).

RSCC system and Tonnage Coverage Certificate

Establishment of EU importer list is a must according to EU REACH. So Non-EU manufacturers shall add importers located in EU member and EEA states in REACH SUPPLY CHAIN COMPLIANCE (RSCC) system, the IT solution developed and owned by REACH24H Consulting Group for REACH data management and supply chain communication globally.

In pursuance of item 2.1.2.5 of ECHA Guidance V. 4.0 on Registration, also to protect Non-EU manufacturer's business interests, it is suggested that for each of actual trade, a "REACH COMPLIANCE IMPORT CERTIFICATE" issued through RSCC system of REACH24H Consulting Group should be applied for, in which it clearly states that the importation taken by the EU importer will be covered, reserved for enforcement activities anytime.

REACH24H will strictly follow confidential rules. And we suggest that to treat your registration number seriously and prevent it from being abused. For RSCC system assistance, find help by emailing to RCUhelp@reach24h.com.

Use and Exposure Scenarios | CSR and eSDS

1. Exposure scenarios including use descriptors are available for substances registered under EU REACH. If an EU importer or his clients finds uses are not covered in the exposure scenarios received, it is strongly to suggest that he should contact the non-EU manufacturer, REACH24H Consulting Group as the Only Representative for this issue; or the EU importer will have to prepare a specific downstream user chemical safety report (DU CSR) in accordance with the Guidance on Downstream users.

2. The Extended Safety Data Sheet (eSDS) is the tool for communicating the relevant use and exposure information. Not each substance of a non-EU manufacturer REACH24H represents requires an eSDS and some of them don't demand a chemical safety report or even a registration at all.



Safety Data Sheet under REACH

Safety Data Sheet, in general, is a tool being used for the communication of hazardous information on chemical products and safety use within supply chains. A non-EU manufacturer of chemicals may have to prepare REACH-compliant SDS for his EU importers. The languages of SDS should be the local ones where the chemical product are introduced into the EU.
